

Terms of Reference (ToR) Researching Scops of Equality in Property Inheritance Rights in Bangladesh

There are 50% of women involved in agricultural labor in the rural areas but despite this equal share of labor, an equal share of land ownership is a rare case for women. Even land holdings for male-headed households are often more than twice the size of those headed by women has been found in a study. During a 2013 study, through an FAO, it was estimated that the proportion of agricultural land owned by women had shrunk from 3.5% to 2% in the last 20 years. It does not help that households headed by unmarried women or widows with only daughters or no children are often excluded from land reform programmes.

Inheritance law and the practice itself might be discriminatory to women and are deferred by statutory law to governance through the different domestic religions. For example, under Islamic law, daughters inherit half the share of land compared to sons, and cultural norms support a daughter surrendering her inheritance to her brothers. A widow receives one-eighth of their husband's property if she has children, and one-fourth if not. However, there is a general risk that property ownership becomes monopolized by paternal relatives rather than passing to direct female kin. Hindu laws rarely entitle women to land inheritance. For which, households headed by unmarried women or widows with only daughters or no children are often excluded from land reform programmes.

In line with the SDG goal, Bangladesh has committed to ending all forms of discrimination against women and girls. However, the pandemic has pressured women for selling only assets land and creating violations in case of inability.

To initiate advocacy, Badabon Sangho intends to conduct research on inherited property rights, particularly investigating civil laws that are associated to promote equality and/or inequality, and put forward policy recommendations.

The audience of this study:

The result of this study will be used to seize the attention of policy actors. Therefore, government officials particularly the law commission, Ministry of Land, Ministry of Women Affairs, and other networks and civil society organisations directly working for women's rights will be the key audience.

Objectives of this Study:

The main objective of this survey is to find out-

- I. Identify opportunities in existing civil laws regarding equal inheritance properties
- II. Investigate specific article/rules/wording that creates inequality in exiting civil laws.
- III. Present the recommendations to policy actors.

Language

The research paper will be written in English.

Drafting report
